ADOPTION CONTRACT

The following agreement is made between **Pawed Pals Animal Rescue Inc. (PPAR)** and

hereinafter known as the **Adoptee**.

The Adopter agrees to the following **Terms and Conditions of Adoption**:

1. To pay PPAR the required adoption fee of \$_____ before the Adoptee is transferred into the Adopter's care.
2. To cover all costs associated with the keeping and care of the Adoptee.
3. To bring the Adoptee into their private residence to live as a household pet, companion animal and member of the family.
4. To give the Adoptee a safe transition space in the home, with sufficient time, care and patience to properly adjust and develop a bond and trust with its human family and any other pets.
5. To provide the Adoptee with adequate nutritious food, fresh water, exercise and stimulation, humane treatment, attention and affection throughout its lifetime.

6. To provide the Adoptee with routine veterinary care, annual examinations, vaccinations as needed throughout its lifetime, as well as immediate and proper veterinary care, medications and necessary tests/procedures if any sickness, disease or injury occurs.
7. To never strike or otherwise abuse the Adoptee; to never leave the Adoptee confined for extended periods of time; and to take all possible precautions to keep the Adoptee safe from harm.
8. To update the Adoptee's microchip and/or tattoo registration records if the Adopter should change their phone number or move to a new address.
9. To make every effort to find the Adoptee if they should ever become lost.
10. To contact PPAR immediately if the Adopter determines the Adoptee to be unsuitable within 30 days of adoption, or if they are no longer able or willing to care for the Adoptee for any reason at any time in its life.
11. That 50% of the adoption fee will be refunded if the Adopter returns the Adoptee to PPAR within 30 days of the date this contract is signed; but no refund after 30 days.
12. Other than relinquishing the Adoptee back into PPAR's care, to never surrender, give or sell the Adoptee to any person, rescue, shelter, pound, veterinarian or any other entity or organization under any circumstances at any time in the Adoptee's life; and to never permit it to be used for experimental purposes.
13. To adhere to the following Special Conditions (please initial this section):

14. That PPAR is not liable for any costs or arrangements associated with the keeping and care of the Adoptee throughout its lifetime, except for pre-arranged services explicitly agreed to and specified above under Special Conditions (if applicable).
15. That PPAR is not liable for any damages, injuries, infections or other harm that the Adoptee may cause to the Adopter, their property, any other person or animal.
16. That PPAR makes no guarantee or warranty, expressed or implied, about the Adoptee's breed, age, history, health, temperament, behaviour or suitability.
17. That this is a legal and binding agreement; and if PPAR finds that any Terms or Conditions of this agreement are not being met, or any false information was provided by the Adopter or their references, that will constitute a breach of contract and the Adopter must relinquish the Adoptee back into PPAR's care on demand.
